FUSION PROJECT - Koppio Hills - Lower Eyre Peninsula.

- Centrex Metals.
- Open cut iron ore mines. Area approx 50kms x 10kms long. 500 square kms area.
- Approx 8 open cut iron ore mines. 3 at initial stage.
- Each one of 3 initial mines, approx 3km x 1km x 250 metres below sea level in the Koppio Hills. (Height of the Koppio Hills is approx maximum of 300 metres).
- One proposed mine would engulf The Tod River.
- 4 mines, crushing and processing plant in The Tod River Catchment Area.
- Iron Mount a proposed mine approx 8kms from Tumby Bay.
- Green patch a proposed mine approx 10kms from Port Lincoln.
- Proposed slurry pipeline to proposed new Port Spencer port, Lipson Cove

Kookaburra Gully

- Lincoln Minerals limited /Australian Graphite Ltd.
- Open cut Graphite mine 700m x 270m by 90 to 100m deep.
